1. **Masks do not work for a virus** because of a virus's small size including Sars-Cov-2, (the cause of Covid19). **ALL** viruses **WILL** penetrate any mask in either direction. Surgical Masks designed to meet government standards will only stop particles 3 microns or larger. The NIOSH N95 designated mask **cannot** stop a virus . That is fact based. N95 masks are designed to stop 95% of particles 3 microns or larger. This information comes from medical textbooks on Microbiology, Virology, specific Mask Studies begun in 1995 and published in early 1998 by the American Association of Occupational Therapists in their monthly journal, and previous standards published by **NIOSH/OSHA**. Masks are **useless** for virus protection. Not an opinion, but fact driven by the information found in those sources. No matter what the NIH, CDC, FDA, NIAID, NIOSH, or OSHA may say, masks are not effective against the Covid causing virus. The NIH and its various departments are clearly and provably misleading all who follow their mask recommendations. Closely examined, all statements by those government organizations (NIH, CDC, FDA, NIOSH, etc.) are only recommendations and not legal government orders, regulations or science-based guidance and **are misleading**.
2. **Covid shots do not protect from Covid19**. There was no statistical difference measured by the drug companies own trial data provided to the FDA of the shots to treat Covid19 disease. On that basis, the FDA issued an EUA(Emergency Use Authority) without knowledge of any side effects which are now well known and extremely dangerous. (See item 8). All three drug company results submitted to the FDA showed people receiving nothing (no shots-placebo) in the required trials had nearly the same outcomes as people receiving the shots. In fact, the no-shot placebo patients did slightly better than those who got the shots however the shots are causing serious side effects. The shots do nothing to protect, and given the harmful reactions to the shots, **do not justify further use of the shots**. Dr. Richard Fleming recommends the President cease all shots **IMMEDIATELY**. There were a combined total of 131,077 patients in the drug makers trial study equally divided into Covid19 shots and "No-Shots" (Placebo). 3. **The CDC patented the virus that causes Covid19 disease**(Sars-Cov-2 virus) two times, once in 2007 and again in 2010. The 30+ listed inventors lived in the Atlanta area. Both these patents are likely **ILLEGAL** under at least two US Laws. The US patents are structured in such a way so that no one can use or apply them including producing test kits to detect the disease. The FDA authorized using the existing Flu Test Kit under an EUA and the Emergency Authority (EUA) was withdrawn by FDA for Covid19 usage, except for specific, designated test labs. Sars-Cov-2 patents held by the CDC meet the Nuremberg definitions of a biological weapon. 4. **Dr. Anthony Fauci paid for research on Sars-Cov-2** (Causes Covid19 disease) by controlling and giving money grants to researchers through second and third parties. The Sars-Cov-2 NIAID (Fauci) paid research was done mostly in China at the Wuhan China Bioweapons Lab owned by the Chinese

Communist Government (Chinese People's army) once the Ft Dietrick MD US bioweapons facility banned any further research of the type Fauci was sponsoring. Dr. Fauci lied about this research to the US Senate (a felony) and is under criminal investigation for doing so. It is known that Fauci continued sponsoring research formerly done at Ft. Deitrich to third parties who further subcontracted the research to the Chinese Wuhan Bio-Weapons facility.

5. **The FDA banned the only effective drug treatment for Covid19**(Hydroxychloroquine-HCQ) in 2020 violating direct orders from the President to make HCQ available to the American people. Usage results of HCQ were published in 2020 in Peer Reviewed Journals and later in a formal journal report of a Clinical Trial. The drug does work as the studies found. The Georgia head of Public Health, Dr. Kathleen Toomey, a current member of the known subversive organization, CFR (Council on Foreign Relations), also attempted to block HCQ use in a letter she sent to ALL GA COUNTY health departments on February 22, 2020 prior to the March 28 FDA ban. Toomey is a Gov Kemp appointee. FDA first banned HCQ March 28, 2020, and again later June 15, 2020. The FDA falsified the basis for those two prohibitions. Those prohibitions are likely illegal under the Pure Food and Drug Act of 1945. The FDA is under an active lawsuit brought against it by the AAPS. (American Association of Physicians and Surgeons) Since the beginnings of FDA in 1945 physicians have had the right to treat a patient with any medication whether approved or not by FDA. The 2020 FDA HCQ ban is likely illegal on its face. There are several effective drug treatments for covid19 including HCQ/Zinc Sulfate, Ivermectin, Regeneron monoclonal antibody infusion, Vitamin C, Vitamin D, etc. Sources for this information include but are not limited to the FDA orders of March 28, 2020, and June 15, 2020.
6. There are now emerging several **curative drugs for Covid19** that are being used widely by doctors to treat their patients. The entire US Government establishment under the NIH had ignored any treatments for the entire years of 2020 and 2021 in favor of a hoped-for Vaccine which still does not exist. Those drugs are Hydroxychloroquine plus Zinc Sulfate vitamin, Ivermectin, and Regeneron.
7. In 2020, **supplies of Hydroxychloroquine (HCQ) were collected by the US government** and placed in storage in the National Strategic Stockpile in violation of direct Presidential orders to make sure HCQ was available to the American people.
8. As **reported in the CDC Open VAERS Report** Covering January 1, to September 24, 2021, Covid19 shots from all three primary drug makers resulted in 15,937 deaths within 48 hours of receiving the shots. In addition, 85,377 people required ER care after getting the shots, 71,036 others were hospitalized, 20,789 were permanently disabled and many very serious side effects numbering in the thousands were noted. CDC added a new reporting number to its VAERS system in recent days with no explanation of how it was derived. The new reported number is the number of adverse events caused by the shots. The Sept 24, 2021, report showed there were 1,519,354 adverse events related to all vaccine's with 752,801 directly related to Covid shots reported. Based on the CDC's own reports/statements, deaths and other effects of the shots are underreported by 87% to 90%. That being the case, deaths from the shots alone are thought to be between 122,592 and 159,370. The three shots have resulted in an unprecedented number of adverse reactions being reported to the government's Vaccine Adverse Event Reporting System (VAERS), including almost 16,000 reported deaths, more

9. **Fort Detrick Maryland US Defense Department Bio-weapons facility** banned research on Sars-Cov-2 "Gain of Function" some years ago.
10. **Covid19 shots are not a vaccine**. Numerous people given the Covid shots later became infected with Covid19 disease and were not immunized by the shots. This is confirmed by several countries such as Israel where 72% of the population who received the shots were infected by Covid disease in a country where 84% of the entire population received the shots. Translated, 86% of the people who got one of the three shots later were infected and sickened by Covid19. This only means one thing. The shots do not protect you from Covid19.
11. **Covid19 shots from Pfizer, J&J, and Moderna are NOT approved by the FDA**. The shots were given an FDA "Emergency Use Authorization" as an experimental drug. The shots have unacceptable levels of dangerous side effects even for an FDA "experimental" drug classification. An EUA is a process that authorizes unapproved, untested drugs for Human use (Right to Try) when there are no other alternatives. There are other alternatives at least two of which have been blocked by the NIH.
12. **Vaccine of all kinds in use in 2009 were found to be contaminated** by a research team funded by the NIAID (Anthony Fauci) The contamination consisted of animal viruses contained in the precursor tissue material used to make the vaccines. That information was suppressed by Anthony Fauci. Millions have been harmed as a result. Those researchers were banned for life from federal medical research facilities for telling the truth.
13. **Scientists and research physicians** in the United States and other countries have stated the Covid19 shots contain toxic chemicals, can penetrate the brain with injury, and have components that infect the entire human body.
14. **There is no valid test for Covid19**. The FDA had authorized one test for Covid19 and allowed its use starting in 2020 and most of 2021 before canceling the use of the test under an FDA EUA authority. The EUA Allowed test was and is the existing test for the Flu. That test cannot tell the difference Between Flu and Covid and was withdrawn by the FDA.
15. **There is NO valid test for any variation of the Covid virus** (Sars-Cov-2). The test used is a computer model which does not actually test the actual Covid virus. The only known test is a special lab test of samples taken directly from an infected person to determine the DNA profile of the sample.
16. **Ivermectin in being used and promoted as a cure for Covid19**. Ivermectin does have some demonstrated anti-viral qualities that appear to influence Covid19 disease. Many countries outside of the US are conducting human trials and testing Ivermectin as a Covid19 treatment in humans with

some success. Some American doctors are also prescribing it as Covid19 treatment. Ivermectin is currently NOT approved by the FDA for human use except as a lotion treatment for Human Head Lice. FDA has issued several letters advising not to use Ivermectin for Covid19 but offer NO supporting information as to why. Ivermectin, owned by Merck Inc., is a veterinary medication for parasites in domestic animals. A few studies show it is not as effective as Hydroxychloroquine plus Zinc Sulfate vitamin for Covid19 (Sars-Cov-2) treatment. Ivermectin was brought to the Veterinary market in 1981 by the Merck Drug Corp. and patent protections have long since expired. Merck so far has done nothing to conduct any human use trials or spend on research for Covid19 use. In 2021, millions were spent by an unknown entity on public relations and advertising for Ivermectin, promoting its use for Covid19. The known Ivermectin research is an in-vitro (In the lab in a petri dish) test of Ivermectin for anti-viral properties which were shown by the drug in those lab tests.

17. **Gilead Sciences of San Francisco** California are owners of a drug called Remdesivir. Gilead has promoted Remdesivir in the past as a Covid19 treatment. Gilead is in the home district of Speaker Nancy Pelosi. A published research report for Remdesivir drug was found to be falsified after publication in the British Journal of Medicine, "Lancet". The report was withdrawn by ("Lancet" when it was found to be falsified. Gilead conducted two studies of Remdesivir for Covid19 in the Wuhan province of China in late 2019. Both were cancelled and one of those studies provably showed Remdesivir had no value as a Covid treatment.
18. **Sars-Cov-2 virus that causes Covid19 disease was created in a lab** by modifying the Sars-Cov-2 DNA and does not exist in nature. The modifications gave the virus enhanced ability to infect Humans. It is known that the virus escaped from the Wuhan China Lab in 2019.

The doctor can give you a prescription for a preventative dose (be sure to ask for that specifically) of Hydroxychloroquine (200mg tablet once per week) along with a daily 200mg Zinc Sulfate vitamin. Those medications can be sent overnight Fedex. Make shipping arrangements with the pharmacy when they call you. Florida's Governor has established more than 20 clinics where Regeneron IV drug treatments can be given. A few Georgia locations and physicians are providing Regeneron infusions including one in Thomasville, Georgia, just a few miles from the Florida state border and some in Cherokee County.
