

COBB COUNTY BOARD OF ETHICS
ETHICS COMPLAINT

On this day of Monday, January 23rd, 2023, Complainant, **Debra J Fisher** of [REDACTED] [REDACTED] seeks a favorable decision from the Cobb County Ethic's Board for injunctive relief through the Superior court to VOID both votes cast by Commissioner Richardson, the first vote was on Oct. 11th, 2022 and the second on October 25th, 2022, approving the Home Rule Resolution and (2) the complaint seeks for censure and / or reprimand created from the impropriety and/or the appearance of such, the fiduciary conflicts of interest created from the Commissioner's registered 501c 4 Corporation created March 7, 2022, the same day of the first executive session of 2023. This complaint is filed against the actions of Cobb County, District 2 Commissioner, Jerica Richardson, who resides at [REDACTED] [REDACTED] Jerica Richardson has violated her oath of office and the Code of ethics under the following Cobb County Code(s) 2-46 and 2-47.

Complaint 1: Sec. 2-47. Abstention to avoid conflicts of interest.

Commissioner Richardson refused to recuse herself from discussions and the votes taken, concerning the Home Rule Redistricting Maps on Oct. 11th and Oct. 25th in 2022 after Commissioner Gambrell requested the recusal due to conflict of interest. Commissioner Richardson has created both a personal as well as a fiduciary conflict of interest. Commissioner Richardson's affirmative vote cast on October 11, 2022 and again on October 25, 2022 were illegally cast thus making the Resolution for Home Rule / and the creation of the maps that went into effect on January 1st, 2023, VOID. Commissioner Richardson also violated the code of ethics by failing to disclose, in writing or verbally, the conflict and the collection of money through the 501c 4 Corporation's website which clearly creates a Fiduciary conflict of interest that disqualifies Commissioner Richardson from participating in discussion in whole or part and from voting on this issue.

Complaint 2 – 2-46 (a) (b) & (c):

Commissioner Jerica Richardson is collecting money via her 501c 4 For Which it Stance's website Drawn-out GA [For Which It Stance](#) and has used her public position through her corporate website to induce, coerce or influence people that provides financial benefits to the Commissioner and her corporation.
