Dear Honorable Raffensperger:

The GA CONST. Art. 9, § 2, ¶ I, Home Rule for Counties (a), states that, "[T]he governing authority of each county shall have legislative power to adopt clearly reasonable ordinance, resolutions, or regulations relating to its property, affairs, and local government for which no provision has been made by general law and which is not inconsistent with this Constitution or any local law applicable thereto." See GA CONST. Art. 9, § 2, ¶ I (a).

Pursuant to GA CONST. Art. 9, § 2, ¶ I, the Board of Commissioners of Cobb County duly adopted a Resolution Amending Local Law on October 11, 2022 and October 25, 2022, causing same to be executed by the Cobb County Chairwoman and filed with the Cobb County Clerk. The Resolution is the SAME, it was duly adopted at two consecutive meetings pursuant to GA CONST. Art. 9, § 2, ¶ I (b)(1), so each duly adopted Resolution is included for filing. (See below, (1) and

In order for the Resolution Amending Local Law to become effective, GA CONST. Art. 9, § 2, ¶ I (g), states that, "No amendment or revision for any local act made pursuant to subparagraph (b) of this section shall become effective until a copy of such amendment or revision, a copy of the required notice of publication, and an affidavit of a duly authorized representative of the newspaper in which the notice was published as provided in said subparagraph has been filed with the Secretary of State." See GA CONST. Art. 9, § 2, ¶ 1 (g).
